

# First Book of Record

St. John's Episcopal Church, Worthington, Ohio

An article of agreement made and concluded upon between the Trustees of St.

John's Episcopal Church in Worthington and parts adjacent and Erie Bristol of all of Worthington Franklin County and State of Ohio witnesses he that the Trustees on their past Government and agree to lease to the said Bristol ten acres of land on church lot bounded as follows. Viz: Beginning at a certaine ash stump standing near a Beech tree marked thence northerly to a Blueash stump where said Bristol made shingles thence due north to the high-way thence west to the bank dividing the first from the second bottom thence along said bank untill the tract is thirty two Rods wide from thence to the first mentioned boundery.

The said Bristol agrees on his part for the use of said land to clear off the above Discribed land and put the same under a good fence each length to contain six good rails. Rails with a good ground log within six years from the first day of March next and at the expiration of the said six years to leave the premises well cleared and the fences in good repair and the said Bristol furthur agrees to build a house and barn on said lot to be appraised at the end of said six years and use of the land to be appraised sufficient to compensate him therefore it is furthur agreed by the parties that the said Bristol clean fence and improve all the land on said lot lying south of the above Discribed tract



for the use thereof seven years from the said first day of March next and leave the premises in good order and repare as above stated the said Bristol is not to waste or destroy any of the following timbers that may be fit for boards shingles or rails or make use of them other than building and fencing on said land without giving one fourth part of the booards and shingles to the Trustees or their successors in office and notifiying them when ready Viz all kinds ash oake walnut Lin and Hickory. - - - - - -

Articles of Agreement. Made and entered into by Sundry persons

Inhabitants of Worthington & Parts adjacent in Franklin County & State of Ohio forming themselves into a Society for the Purpose hereinafter expressed.

To all whom it doeth, or May concern, by these Presents be it known.

That we whose Names are under written agreeing in Sentiment with the

Faith, Worship, and principal Doctrines, of the Protest. Episcopal Church; 
as regulated and established in the United States;- have formed ourselves into a

Religious Society by the name of ST. JOHN'S CHURCH IN WORTHINGTON AND PARTS

ADJACENT: untill Legally Incorporated; - and have adopted the following

provisional Articles for our regulation and bond of Social Union till a more

definitive Constitution shall be prepared and adopted. - viz.

#### Art. 1st.

There shall be appointed before the present Convention dissolve, a

Moderator and recording Clerk, - There shall next be chosen Three Trustees who
shall receive in trust the care of the Lands given to this Society by the Scioto

Company, with all the public property, and the Management of the funds, and the
other prudential business of the Society. - Either Two of the said Trustees duly
met according to appointment shall form a quorum and may proceed to business
accordingly: - and the Trustees at all times acting in their public Capacity
shall be denominated, the BORD OF TRUSTEES FOR ST. JOHN'S CHURCH, &c.

The person chosen as the first Trustee shall act as agent of the

Society in all Common concerns, where no special agency is deemed necessary; and
also, as Auditor of the Accounts; - and it shall be his duty at every annual



Meeting of the Society to exhibit a fair Statement in writing of the Situation of the funds and the public accounts, with the exact Itims anexed; - and the same being publicly read in open Meeting shall be Lodged in the files of the Auditor's Office, and a duplicate of the same made out by the said Auditor, in the office of the Clerk.

There shall also be chosen two Church Wardens who shall have in Trust all the private property of the Church, as Such, and shall be accountable for the same when thereto required by a Church Meeting.

There shall next be chosen a Treasurer, with whom shall be deposited all unappropriated Monies of the Society, and to whom, or his Successor in Office, all obligations in favour of the Society shall be drawn payable.

There shall then be appointed, a Reading Clerk, One or more Tithingmen, and a sufficient number of Choiresters - and the Officers so Chosen, shall hold their Offices respectively, till others are Elected and duly quallified.- and no person shall be declared elected to any of the said Offices, but by a Majority of the Votes of the Members present and Acting.

Art. 2nd.

The annual Meetings of this Society shall be holden on the Monday Next after Easter-Sunday in each Year in the Town of Worthington; at the Usual place of holding other public Meetings; - and at such hour of the day as the Society May from time to time agree upon.



Art. 3rd.

The Officers of this Society shall be Elected Annually (after the first election already provided for) at the said Annual Meetings, beginning on the first Monday after Easter-day next, and May be appointed by Nomination & hand Vote, or otherwise, as shall be found convenient from time to time, excepting the Trustees & Treasurer but these, shall in all cases be elected by Ballot, delivered to the Moderator with the names of the Candidates fairly written.

## Art. 4th

Any person living- in parts adjacent to this Town may become a Member of this Society by signing the Articles of Agreement, or constitution;- and being so a member shall be entitled to receive all the priveliges of the Society in common with the original Members be bound by all the votes and resolutions passed by the Society, so as he shall continue a Member;- and any person having once entered his name as a Member of this Society shall be considered & holden as Such untill he shall lodge a Certificate under his hand with the Clerk, declaiming, that he has withdrawn himself from the Society and chooses not to be considered any longer as a member, and from and after the entry of his said Certificate with the clerk, such person shall be exempted from any obligation, or liability on account of vote of the Society passed Subsequent to the entry of his Said Certificate;- and it shall be the duty of the clerk to receive any certificate so offered, and immediately to enter on the back of the same the day of the Month and the Year when entered, and the same to record at length in the



Books of the Society as Soone as convenient and that without any fee from the person so lodging his Certificate.

Art. 5th.

When any number of persons living in parts adjacent to this Town, and at a greater distance than five miles, shall become Members of this Society, & shall manifest a wish to have service performed with them in the different parts where they reside, they shall (upon their appointing some convenient place or places as the case May be for the purpose, for the accommodation of all concerned) be entitled to have service performed, and the Ordinance of the Gospel Administered with them at the place or places so appointed, their Just proportion of the time according to their numbers and contributions, by the Clegiman, or Other Officiating person, who may from time to time be imployed in the Society; Provide however always; - that the time the Officiating person shall be absent from Worthington, in such Adiacent parts, shall not exceed two Sundays in a month, or twenty four Sundays in a year, - and Provide also, that all Holy days of Fasts & Festivals shall be kept at the Usual place of Meeting in Worthington. And should it ever be the case, that so many should join themselves to this Society living at a greater distance than five Miles as aforesaid as that by an equal apportionment of the time, they would draw more than the twenty four Sundays in the Year, then the Members in the several Adjacent Settlements (should there be more than One) shall apportion equally between themselves according to their Numbers, &c, the twenty four Sundays that will be their right In each year;- and another twenty four Sundays in a year shall forever be the right of the Original Society in Worthington and when there shall be five



Sundays in a month, the Service for Said fifth Sunday shall always be at the disposal of the Clergiman, or Other Officiating person either at Worthington, or in Some distant parts.

In testimony that we have Voluntarily entered into the foregoing articles of Agreement, & will with good faith observe the same we have hereunto set our hands in presence of each Other. Done at Worthington this 6th day of February A.D.1804

An act to incorporate the Society of St. John's Church, in Worthington and parts adjacent.

Section I.

[Members of the Corporation.]

Be it enacted by the general assembly of the State of Ohio: That James
Kilbourne, Ezra Griswold, Thomas Palmer, Samuel Beach, David Bristol, Alexander
Morrison, Israel Case, Isaac Case, Lemuel G. Humphrey, Obed Blakesly, Samll
Beach, Jur., Adna Bristol, Ebenezer Brown, Levi Pinney, Israel P. Case, Abiel
Case, William Robe, Noah Andrews, Joseph Sage, Abner Pinney, Elias Vining,
William. Vining, William Morrison, Aaron Strong, Roswell Tuller, William
Watson, Seth Watson, Nathan Carpenter, Ira Carpenter, and their associates for
the time being be and they are hereby created and declared a body politic and
incorporated, in law and in fact, by the name of St. JOHN'S CHURCH, in
Worthington and parts adjacent,

and as such shall remain and have perpetual succession, Subject, however, to such alterations and restrictions, as the Legislature may from time to time think proper to make.

Section II.

[(Capable of sueing and being sued in their corporate capacity. To have one



# common seal.]

Be it further enacted that the said Corporation shall be capable in law, by their name aforesaid, of sueing and being sued, of pleading and being impleaded, in any suit and in any court, proper to try the same: and they are hereby authorized to have one common seal for the use of the Corporation, and the same to alter, break, or renew at their pleasure.

#### Section III.

[Their powers in receiving and acquiring property.]

Be it further enacted, that the said Corporation shall be capable in law by the name aforesaid, of having, receiving, acquiring and holding either gift, grant, devise or purchase, any estate real, personal or mixed, which now is, or that shall hereafter become the property of said Society, together with their proportion of the profits or rents arising from any lands given by Congress for Religious purposes provided; however, that the clear annual income of all such property, shall not exceed the sum of three thousand Dollars, and that no part thereof be appropriated to any other purposes than the following [Limited.]

viz: of erecting and keeping in repair a house of public worship and all other necessary and convenient buildings for the accommodation of the Minister of said Society for the time being and of enclosing and keeping in repair the graveyard; [Money &c. how to be applied.]

of clearing and improving the lands belonging to the Corporation, of defraying the expences Incident to their mode of religious worship generally, of affording relief to the poor, and (if necessary) supporting a school for all of which



purposes, they shall have full Power to make appropriations in such manner and proportions as they shall judge expedient and proper [Proviso.]

Provided Also, that every specific gift, donation, or devise, shall be appropriated by the Corporation in such manner and for such purposes, as shall be designated by, or that shall be in pursuance of the intention of the donor or devisor.

Section IV. Be It further enacted; That for the better regulating and governing said Society, and managing the affairs thereof, there shall be a meeting of the corporation at said Worthington on the first Monday of the Easter Sunday, annually, at one o'Clock in the P.M. and being so met, they shall first appoint, in such a manner as they shall think proper, a Moderator, who shall preside in said meetings, and cause due order to be observed.

[Annual Meetings of the Corporations.]

They shall then proceed to elect three Trustees, a Treasurer, a clerk,, and a collector and such other officers as the Corporation may find necessary, who shall hold their offices one year and untill their successors shall be elected and duly qualified,

[Proviso.]

Provided: That if by any neglect, or casualty, an election of the officers should not be made on the day appointed for the annual Meeting, or in the event bar a vacancy by Death, removal, or otherwise, the Society may elect their officers, or supply such vacancy at any meeting of the Corporation duly appointed.



## Section V.

[Election to be by ballots.]

Be it further enacted, that, all the elections of the Corporation shall be by ballot, and a person having a majority of all the ballots given for any office, shall be considered duly elected; and all votes in Society matters, shall be determined by a majority of Members acting in any meeting of the Corporation duly assembled.

#### Section VI

[Trustees to call Meetings. Notice to be given.]

Be It further enacted; That all meetings of the Corporation either for the election of officers or for the transaction of the other business of the Society, shall be called by the Trustees or a majority of them who shall cause notifications in writing to be posted up in three public places in said Worthington, at least fifteen days previous thereto, mentioning the time, place, and object of such meeting.

# Section VII.

Be It further enacted, that the Trustees or a major part of them, shall have power and authority to make all contracts in behalf of the Corporation which shall be necessary to carry into effect and accomplish the object of the institution, and manage all pecuniary and prudential matters and other concerns which pertain to the good-order, interest and welfare of the Society, and make such rules, regulations and byelaws for the Government of the Societly, and for



regulating and conducting the affairs of the same, as, shall from time to time be deemed necessary and expedient. Provided, That such rules, regulating and byelaws

[Proviso.]

be not inconsistent with the Laws of the United States or this State, and that the same, before they have effect be approved of by the corporation; Provided, also; That all monies which constitute the fund of the Society shall be applied to such purposes only for which they shall have been appropriated by the Corporation or specifically given by the donor, or devisor.

#### Section VIII

[A person wishing to become a member has to apply.]

Be it further enacted, That whenever a person shall wish to become a member of said Society he shall have a right so to do, by applying to the Clerk and subscribing his name the bye-laws and ordinances adopted for the government of the corporation, and thereupon he shall become a member of said Society, fully entitled to a participation of all the priviledges and immunities, and subject to all the rules and determinations of the corporation in common with the original subscribers, so long as he shall continue to be a member; and furthermore whenever any person that now is, or that shall hereafter become a member of said Society shall wish to withdraw himself from the corporation, he shall have full right and power so to do by lodging a certificate under [Wishing to withdraw, lodge a certificate with the Clerk &c.] his hand and seal with the Clerk stating such his wish, and that he is not, therefore to be considered as a member, and the clerk, immediately upon receipt



of any such certificate shall endorse thereon, the date when received and record as soon as convenient both the certificate and the endorsement at length, in a Book provided for that purpose by the corporation. And the Clerk (if required) shall give to any person withdrawing from the Society as aforesaid a writing under his hand and seal, acknowledging the receipt of such certificate, and that without any fee or reward from, such applicant.

Section IX. Be it further enacted, That the Treasurer shall give Bond with sufficient surety, to the Trustees end their successors in office, in such sum as the trustees shall deem sufficient conditioned,

[Treasurer to give bond and surety to the Trustees.]

for the faithful performance of those duties that may appertain to his office, by the rules, regulations, and bye-laws of the corporation All process against the corporation shall be by summons, and the service of the same shall be by leaving an attested copy thereof with the treasurer of the Corporation, at least twenty days before the return.

Section X. And be it further enacted, That James Kilbourne, Ezra Griswold and Thomas Palmer, be and they are hereby appointed Trustees; Ezra Griswold, Clerk, and Samuel Beach Treasurer of the corporation, to continue in office untill the first Monday after Easter Sunday next, and till others are elected and qualified in their place, And the said first Monday after Easter Sunday next, is hereby appointed for the first annual election of said corporation.

This act to take effect from and after the passage thereof.

The Trustees for the year ending this day, made a Report of their proceedings, and a statement of the Account of the Society, which Report and Statement were accepted & approved, and the thanks of the Society voted to s'd Trustees, for the diligence, zeal and ability they have exercised for the Society, by which the condition of its affairs have been much improved.

The following resolution was then voted.

Resolved that it shall be the duty of the first Trustee of St. John's Church to take into safe keeping the Scrip of Stock in the Worthington College together with the Proxies now on hand, or which may be hereafter received, and hand the same over to his successor in Office, that the Trustees may know where to find them at any tine when wanted. -

Voted. that the Person who recently out Timber and split about two hundred rails on the Societies Wood Land, without leave, and claimed pay for his labour since the Trustees sold the Rails should receive no pay from the Society.

#### BY - LAWS

And ordinances for the Corporation of St. John's Church in Worthington and parts adjacent, passed Easter Monday, April 23rd, 1821.

#### Article I.

This Society receive and adopt the Constitution of the Protestant Episcopal Church of the United States of America, as also the Faith, Worship, & Doctrines taught therein.

## Article II.

The Annual Meeting of the Society shall be holden on the first Monday after Easter Sunday (according to this Act of Incorporation) at which rieetin- Divine Service shall be performed according to the Liturgy of the Protestant, and the Rector of the Parish (if present) shall act as Moderator, but if absent, or there is no Rector belonging to said Parish, or Society, then a Moderator shall first be chosen by nomination (the same regulation shall also be observed at all special Meetings of the Society) they shall then elect by ballot three Trustees, a Treasurer, Clerk, and Collector (as provided by the Act of Incorporation) after which their shall elect two Wardens and as many Delegates to the State Convention as the Society shall determine to send- the other Officers, viz:



reading Clerk Choristers and a Sexton, shall be appointed by the Rector - but in case there should be no Rector in the Society, they shall at their annual meeting elect one Reading Clerk, two assistant Reading Clerks, four Choristers and a Sexton. The duties of all the above named Officers, not determined upon by the Act of Incorporation, are settled by the rules and regulations of the Protestant Episcopal Church of the United States of America.

#### Article III.

The Treasurer before entering upon the duties of his Office shall give bond to the Trustees, in such sum as they shall require for the faithful performance of his duty and the paying over to the order of the Trustees all monies or other property by him received. He shall then take in charge all monies subscriptions, and other Personal Property belonging to the Society (except the Church furniture which is always at the disposal of the Rector. He may, also, Previous to the delivery to the Collector, of any Tax - Bill, subscription Notes or accounts for collection, require of him a Bond in the full amount of such Tax, subscription or other demand. He shall also report the state of the funds at each annual Meeting of the Society.

#### Article IV.

No Tax shall be laid by the Society except at their annual meeting, or a meeting specially called for that purpose, and the object of such meeting stated in the notification agreeably to the provision of, the Charter.

#### Article V.



It shall be the duty of the Collector, to collect all demand in favour of the Society end pay the money or other property so collected over to the Treasurer, and he is required when so ordered

by the Trustees to prosecute in the name of the corporation all defaulters. He shall be allowed by the Trustees, such compensation for his services as they shall think reasonable.

Article VI.

It shall be the duty of the lst Trustee to keep a Record of all the proceedings of the Trustees, and report the same as well as the state of the Corporation at each annual Meeting.

## **TRUSTEES REPORT for 1821**

The Trustees on commencing the duties of their office one year ago, found that there had been no settlements made with the Treasurer-Collector or with the Rector of the Parish for nearly two years. There had been a settlement made sometime In July 1818 which settlement embraced only the first year of the services of our present Rector, at which time there was due him \$572 and during that year there had been an endorsement made on that sum of \$85.. - There was considerable sum due the society on subscriptions which had been circulated in 1815 and 1817. The Trustees also 1819 caused subscriptions to be circulated and obtained \$389: this was for the expences of 1818 as no subscription had been circulated during that year. For 1819 the year before our appointment no subscription had circulated. We therefore first attempted to raise something for the past years but our success was poor; we got only \$285 subscribed. On



the 16th June 1850 immediately after the end of the third year of the services of our present Rector, we made a settlement with him for two years then passed but believing it to be proper that the Recotor's year should end at the annual meeting of the Society in order that the Trustees (whose offices would then expire) might be enabled to make a settlement and report the state of the Society at each annual meeting. We therefore settled the amount only to Easter Monday, 1820., Found due him for services rendered in this Parish only \$635.63. The Rector had officiated a considerable part of those two years in Columbus, Berkshire, and Delaware, for which services St. John's Church was bound to pay by the articles of settlement with him, but he kindly offered to leave those places and the time spent out of the settlement and receive for his services whatever those Parishs should feel disposed to give. The Trustees made out accounts against them according to the services rendered them separately and each of the Trustees took a Parish and went and endeavored to persuade them to pay at least a part of the demands against them informing them what the Rector had told us, that he would give into them by way of donation a very considerable of what was due from, them provided they would pay the rest. This was all we could do. We next drew up and circulated a subscription for the year ending, this day but could obtain only \$215. The Trustees who were our immediate predecessors had leased to the Rector the Glebe lot at \$5.00 per acre per annum, only 27 1/2 acres came into his possession the year ending this day in consequence of other leases which had not expired which leases were given for the purpose of having the land improved. For the year now commencing he will have in possession 29-1/2 acres and the next year 59-1/2. We found there had been resolutions passed at one or two annual meetings of the Society authorising



the Trustees to settle with an account with Mark Seely for services as Sexton and wood found for the Church for two years, 1817 and 1818. There was also an account of the same kind with Milton Greer for one year 1819, but no settlement made with either. These accounts have been settled allowing them \$25. per year as the duties of Sexton at this time was very laborious in consequence of the Masonic Society holding their meetings in the same room where Church was held, and during M. Greer's time the joiners and masons were finishing the room. We have also paid a judgment against the Society in favor of Hector Kilbourn of \$43.60. Several other accounts have been settled in the course of a year indeed all the accounts (except one with W.M. Co - a note in the hands of Moses Wilkinson of about \$11. and some other subscriptions) that we have been able to find standing with the Society have been settled. We have also with the aid of the Collector settled most of the subscriptions. The Treasurer's and Collector's accounts old & new and with the Rector for the year ending this day. The result of all which will appear by the annexed statement of accounts. It will be proper for to remark here however, that the Rector in all cases has allowed for produce and labour done for the prices which were known to exist in 1817 the time he first settled with us, and has thrown off a considerable part of his services for the Year past and more than \$350 of the old account due him from this Parish. This is saying nothing of what he has given in to the Parishes which we have understood to be a large amount. We have so much difficulty in being connected with other societies in our accounts that we have determined to have no more to do with them in that way and left it at the Rector's option to go there or not as he thinks proper but for us not to be accountable for any services rendered them. The Trustees have found that



trespasses have been committed on the Glebe lands reserved for wood and timber and have used their utmost exertions to find out the trespassers and succeeded in some degree with some of whom they have settled and received pay. The others have been charged with the timber cut but no settlement made with them. Some of them are probably in such circumstances that nothing can be collected from them. We have agreed with R. Stanbury Esq. to inclose the word lot east of town with a fence: This will be done without any expence to the Society at present; but when ever the society wish to occupy their lot they must make all the division fence between them and the said Stansbury. We were of opinion that if the land was inclosed with a good fence people would be apt to cut and break timber. We have agreed to allow the present sexton for his faithful services for the past year \$15 for Sundays and Holy days not including wood. Several members of the Church it is found are willing to take the duties of Sexton for the ensuing year for the same sum and agree at the same time to subscribe to the society \$5 the same as Mr. Glass our present sexton has done -

To the members of St. John's Church at the annual meeting on Easter Monday 1822.

Gentlemen:-

Being about to remove from the place into the limits of the Church at Delaware it is not probable I shall attend at your meeting Easter Monday. I intend before that time to withdraw Myself from St. John's Parish and attach myself to the parish at Delaware and being the only Trustee now here your society will be left without a Trustee or auditor of accounts at Easter I have thought proper to make the following report to be handed in by the clerk it will appear by tale minutes of last Easter's meeting that Mr. Mark Seely, Mr. Caleb Howard and Myself were elected Trustees. I had prepared a subscription paper for the purpose of raising funds for the support of the Clergyman for the past year and offered to those present on that day. A few made their subscription and others put it off or refused. Soon after the Easter meeting Mr. Seely left



the country. Mr. Howard and myself however used our best endeavors to raise the sum necessary to support our clergyman but have had very poor success. We continued to offer the paper whenever we thought there were any prospects of success untill last fall when Mr. Howard moved to Delaware and left me the only trustee in the parish. I have since used my best endeavors to get subscriptions with very bad success. Some time early in the Winter after being satisfied no more could be done I gave the paper to the Collector requesting him to urge payment either to the treasurer or to Mr. Chase but I have been informed that very little is paid of the small amount subscribed: for myself I am satisfied that under present circumstances it is impossible for the parish of St. John's to raise funds to support their clergyman unless they do it by taxation and forcing Collection which would be very disagreeable and unpleasant and probably the means of driving a majority from the corporation. The Trustees will charge Mr. Chase for the past year the rent of 30 acres of land at 5: if any thing now has been paid for the past year it will appear by receipt or his orders. It is to be hoped for the honour of the Church a-rid parish of St. John's that the Trustees who may be elected at the annual Meeting on Easter Monday will immediately go and settle with Mr. Chase and I should think it best to have an adjourned meeting of the corporation to hear this report and ascertain the state of their affairs and devise ways and means what to do next. From this time forward the yearly rent to be charged to Mr. Chase will be about three hundred dollars in consequence of the leases of Mr. Benedict having expired and this land coming into the hands of the corporation and leased to Mr. Chase. As I have said Mr. Benedict's having expired and he came to me to go over the ground and fulfilled his contract and see if he had fulfilled his contract and if so to



exchange papers and give up leases. I went accordingly but having some doubts on my mind whether they were fulfilled on his part and being alone I have thought proper to omit that business untill after the election and there will be three Trustoes to act and consult together. I have therefore handed the leases to the Clerk again. Esq. Starsburv has not fenced in the church wood lot according to verbal agreement and I am not informed of his intention about it. Ten Shares of certificates of shares in the Worthington College left In my hands as first Trustee I have given to the Clerk as also Thomas Palmer's conveyance of his stock \$40 which entitles St. John's Church to one more vote and they will have a fraction on the Corporation of the College Books of \$1600 - Several proxys given to the Trustee I have also handed to the Clerk. - I have spent much time for the Society during the last two years and my means being very limited I have charged five dollars there is also a subscription against me of five dollars and I therefore consider myself even with the corporation.

1st Was the Treasurer according to the 3rd artickle of the By-Laws taken in charge all moneys subscriptions and other personal property belonging to the society

2nd Has he allways or ever given bond according to said artickle and the 9th Section of the act of incorporation

3rd Has he in the disbursment of such moneys or property as he has received, in all cases paid the same to the order of the Trustees, according to said third artickle and retained the proper vouchers



4th If any money belonging to the society has been received and disbursed by the Trustees to report the amount, and by what authority they have so acted, and whether they had previously given bonds

5th Has the first Trustee kept a record of the proceedings of the Trustees and reported annually according with the 6th artickle of the By-Laws

The fourth section changed so as to read as follows

Be it further enacted that for the better regulating and managing the affairs of said society there shall be a meeting of the Corporation at said Worthington on the first Monday after Easter Sunday annually at which time they shall elect not less than five and not more than ten Vestrymen, a Treasurer, a Clerk and a Collector and such other officers as the corporation may find necessary, who shall hold their offices one year and untill their successors shall be elected and qualified.

Provided That if by any casualty or neglect an election of officer should not be made on the day appointed for the annual meeting or in the event of a vacancy by death removal or otherwise the society may elect their officers at any meeting of the corporation duly appointed.

The fifth section remain in its present form.



The sixth section to be stricken out.

The seventh section change so as to read as follows

Be it further enacted That the vestry or a major part of them shall have power to make all contracts in behalf of the corporation which shall be necessary to carry into effect and accomplish the objects of the institution and manage all pecuniary and prudential concerns which pertain to the good order, interest and welfare of the society and make such rules, regulations and by-laws for regulating and conducting the affairs of the same as shall from time to time be deemed necessary and expedient Provided That such rules regulations and by-laws be not inconsistent with the laws of the United States or of this State and that the same before they have effect be approved of by the corporation provided also That all monies which constitute the funds of the Society shall be applied to such purposes only for which they shall have been appropriated by the corporation or speciffically given by the donor or devisor.

The following to take the place of the eight section

Be it further enacted that no person shall become a member of this society

untill he shall have subscribed his name to the by-laws and ordinances of the
corporation and thereupon he shall become a member of said society fully
entitled to a participation of all the privileges and subject to all the rules
and determinations of the corporation.

The ninth and tenth sections shall remain in their present form except in the ninth section where the word Trustees occurs the word Vestry be inserted
